Szanowni Państwo,

Aleksander Magiera, dziecko Moniki Magiera, planowany termin porodu 20.09.2017 roku został zakwalifikowany do leczenia operacyjnego wrodzonej wady serca w Klinice Uniwersyteckiej w Münster. Koszt porodu oraz leczenia operacyjnego (tj. operacji, pobytu w szpitalu i niezbędnych badań dadatkowych) wynosi ok.60.000 Euro. Jeżeli pobyt przedłuży się lub wystąpią poważne komplikacje koszty leczenia mogą wzrosnąć. W związku z tym rodzice proszeni są o wpłacenie sumy zwiększonej o 20% wyjściowej kwoty (tj. 72.000 Euro) pokrywajacej częściowo ryzyko wzrostu kosztów, która w przypadku gdy leczenie przebiegnie zgodnie z planem zostanie zwrócona.

Operacja jest planowana na wrzesień 2017 roku.

Koszt porodu i pobytu matki na oddziale ginekologiczno-położniczym wynosi <u>dodatkowo</u> około 4.800 Euro.
